PAYMENT SCHEDULE: To confirm a cruise reservation, we require a \$400 per person deposit within 7 days of booking. A subsequent payment of \$1,500 is due April 15, 2018. Final Payment is due July 15, 2018. A 25% deposit is due on all Pre- and Post- Cruise land packages. Final Payment on Pre- and Post- Cruise land packages is due July 15, 2018.

CANCELLATION CHARGES: In the unfortunate event a guest must cancel travel, notice to Burnt Store Travel LLC (BST) must be in writing via email. The effective date of the cancellation is the date we receive the written notification. Cancellation charges are per person, based on the cancellation date, as follows: Prior to 4/15/18 - \$200 loss of deposit, \$200 to be retained as a credit toward a 7-night or longer future AmaWaterways River Cruise booked through BST. 4/15/18 to 7/14/18 - 60% of cruise and land deposits; 7/15/18 to 8/31/18 - 75% of cruise and land price; 9/1/18 to 9/30/18 - 85% of cruise and land price; 10/1/18 to departure - 100% of cruise and land price. After travel begins, there is no refund for unused services, or unused portions of cruise, cruise/tour or airfare. Once airline arrangements as quoted by AmaWaterways have been accepted, an additional non-refundable deposit (\$350 per person for economy class and \$600 per person for business/first class) is required to confirm said arrangements. Certain airline tickets require non-refundable, full payment at the time of reservation.


